A National level seminar was organized by the department of MBA titled ‘Energy Security and Renewable Energy Management’.

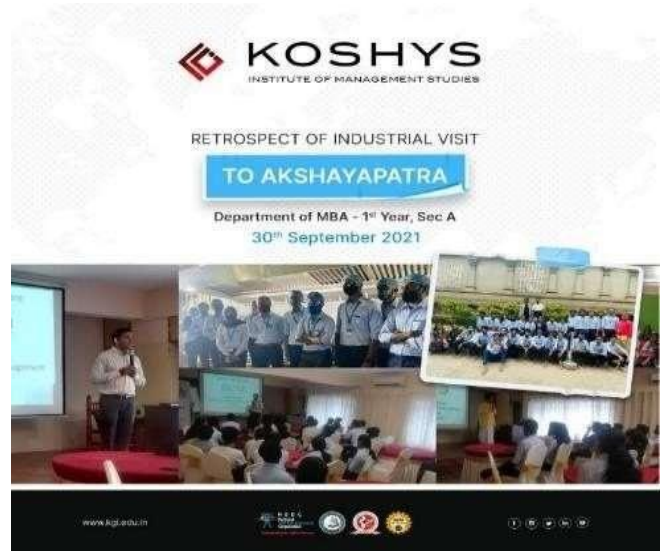
